	DUAL ENROLLMENT
Practice	The parent of an eligible child who is age three or four has the right to dual enroll the child in both the public and private school beginning on the child's third birthday and continuing until the end of the school year in which the child turns five or until the child is eligible to attend the LEA's kindergarten program, whichever comes first.
