<a href="#"><u>Practice</u></a>	<p>All children with disabilities residing in the state, regardless of the severity of their disabilities, and who are in need of special education and related services, must be identified, located, and evaluated.</p> <p><b>Citations:</b> <a href="#"><u>300.111(a)(1)(i)</u></a></p>
<a href="#"><u>Practice</u></a>	<p><i>Special education</i> means specially-designed instruction, at no cost to the parents, to meet the unique needs of the child with a disability, including instruction conducted in the classroom, in the home, in hospitals and institutions, and in other settings; and instruction in physical education.</p> <p><b>Citations:</b> <a href="#"><u>300.39(a)(1)(i)-(ii)</u></a></p>
<a href="#"><u>Practice</u></a>	<p><i>Specially-designed instruction</i> means adapting, as appropriate to the needs of an eligible child under the Individuals with Disabilities Education Act, the content, methodology, or delivery of instruction:</p> <p><b>Citations:</b> <a href="#"><u>300.39(b)(3)</u></a></p>

<u>Practice</u>	<p><i>Child with a disability</i> means a child who was evaluated according to the <a href="#">EVALUATION</a> frameworks and determined by an <a href="#">ADMISSION, REVIEW, AND DISMISSAL COMMITTEE</a> to have an intellectual disability, a speech or language impairment, a visual impairment, a serious emotional <del>disturbance</del> disability, an orthopedic impairment, autism, traumatic brain injury, other health impairment, a specific learning disability, deaf-blindness, multiple disabilities, or who is deaf or hard of hearing, and who, by reason thereof, needs special education and related services.</p> <p><b>Citations:</b>  <a href="#">300.8(a)(1)</a>  <a href="#">TGC 392.002</a></p>

<b>RIGHT TO INFORMATION</b>	
<a href="#">Document</a>	<p>Each school year, the LEA must notify the parent of every non-special education child who receives assistance from the district for learning difficulties, including the use of intervention strategies about such assistance. <b>NOTICES UPON DISCIPLINARY ALTERNATIVE EDUCATION PROGRAM (DAEP) PLACEMENT AND RELEASE</b>	
<u>Practice</u>	<p>On the placement of a child in a DAEP, the LEA will provide information to the child's parent or person standing in parental relation to the child regarding the process for requesting a full individual and initial evaluation (FIE).</p> <p><b>Citations:</b>  <u>TEC 37.006(p)</u></p>
<u>Practice</u>	<p>Not later than five instructional days after the date of a child's release from an alternative education program, the campus administrator will coordinate the child's transition to a <del>regular</del><u>general</u> classroom. The coordination will include a personalized transition plan for the child, developed by the campus administrator that includes the provision of</p>
