<a href="#">Document</a>	<p>The evaluation data reviewed by the group of qualified professionals in connection with the determination of the child's disability based on deaf-</p>

	<b>ELIGIBILITY CRITERIA</b>

<a href="#">Document</a>	<p><i>Deaf-blindness</i> means concomitant hearing and visual impairments, the combination of which causes such severe communication and other developmental and educational needs that they cannot be accommodated in special education programs solely for children with deafness or children with blindness.</p> <p><b>Citations:</b></p> <p><a href="#">300.8(c)(2)</a></p>

<a href="#">Document</a>	<ul style="list-style-type: none"> <li>Meets eligibility criteria for visual impairment and has a suspected hearing loss that cannot be demonstrated conclusively, but there is no speech at an age when speech would normally be expected, as determined by a speech/language therapist, a certified speech and language therapist, or a licensed speech language pathologist;</li> </ul>

<a href="#">Document</a>	<ul style="list-style-type: none"> <li>Has documented hearing and visual losses that, if considered individually, may not meet the requirements for deaf or hard of hearing or visual impairment, but the combination of such losses adversely affects the child's educational performance; or</li> </ul> <p><b>Citations:</b></p> <p><a href="#">89.1040(c)(2)(C)</a></p>
<a href="#">Document</a>	<ul style="list-style-type: none"> <li>Has a documented medical diagnosis of a progressive medical condition that will result in <del>related auditory concomitant hearing</del> and visual losses that, without <del>the provision of</del> special education <del>intervention services</del>, will adversely affect educational performance.</li> </ul> <p><b>Citations:</b></p> <p><a href="#">89.1040(c)(2)(D)</a></p>
